#### **Our Banquet Speaker** David Kennedy

Founder and CEO of TrustedSec and Binary Defense, David Kennedy, will speak

at our annual January banquet. Prior to starting TrustedSec, Kennedy was the CSO for Diebold Incorporated, a Fortune 1000 company, with locations in over 80 countries. He developed a global security program that tackled all aspects of in-



formation security and risk management. Kennedy started his professional career as a member of the United States Marine Corps (USMC) and was deployed to Iraq twice for intelligence related missions.

Kennedy has had numerous guest appearances on Fox News, CNN, CNBC, MSNBC, the Huffington Post, Bloomberg, BBC, The Katie Couric Show and other high-profile media outlets. In addition, his tools have been featured on a number of TV shows and movies. Kennedy has assisted in some of the content for the widely popular Mr. Robot TV show and advises on other news organizations and TV shows, including the History Channel.

Include a liquidated damages clause

in your contracts as an easy way to dissuade contract breaches and make future litigation cheaper. A liquidated damages clause sets

out in advance the amount that a breaching party has to pay you in the event of a breach. A lot of litigation goes into establishing how much, exactly, one party has to pay the other when a deal falls apart. By setting that amount out in advance, you can dissuade the other side from breaching, and more quickly get judgment in your favor if you have to file a lawsuit.

GMS and Eddy's Bike Shop have already signed on as sponsors for the July 27, 2019 event. We welcome sponsors, volunteers and participants.




