The program will highlight 10 dangerous apps that kids are currently using and that parents need to know about. Many of these apps can make kids easy targets for sexual predators and bullies. Knowledge of how these apps work and how they can be misused is so important.

Admission is free and no advance registration is required. This is an adults-only program.

Chamber does its part for state tourism and historic preservation

The Richfield Chamber of Commerce can be proud of the tourism that it brings to the area and to the state. Each year people from all over the country drive or fly to this area to participate in the Sweet Corn Challenge. Many stay in the area for extended days.

According to recent reports, tourism is a \$38 billion industry in Ohio and for every dollar spent, tourism returns about \$14.

In Richfield the Challenge has provided Richfield a direct economic impact of \$1.7 million by leveraging the profit of the 22 years of the event to provide grants to the "downtown" commercial historic district. The invest-

ments of the property owners more than quadrupled the grant amounts that they received. Before the Sweet Corn Challenge most of the buildings were in disrepair and some were vacant. Now they are all occupied with active businesses.

In light of this success, The Richfield Town Trust, the 501-C-3 arm of the Chamber, recently approved extending the historic grant process to coincide with the entire commercial historic district of Richfield. Thank you to everyone for your past support.


For those of you who have time for only one business related book a month, the Richfield Branch Library has gone into the shelves to narrow down trending title suggestions.
