for unpaid wages or overtime under the Fair Labor Standards Act. An "employer" under the Fair Labor Standards Act is any person acting directly or indirectly in the interest of an employer in relation to an employee. The FLSA contemplates there being *several simultaneous* "employers" who may be responsible for compliance with the FLSA.

It's doubly important to put in safeguards to appropriately track employee hours and offer compensation or you could find yourself *personally* liable for noncompliance.
