
#### BUSINESS BOOKS

For those of you who have time for only one business related book a month, the Richfield Branch Library has gone into the shelves to narrow down trending title suggestions.

#### Start-Up City: Inspiring Private and Public Entrepreneurship, Getting Projects Done, and Having Fun

by Gabe Klein. Island Press, 2015. ISBN: 0781610916905

At the last Chamber luncheon, President of the Richfield Board of Trustees Janet Jankura touched on a need for the township to revitalize the business districts. Attracting and keeping business in any location is hard work. But it shouldn't be up to the local government alone (yes, really!), or a few individuals/businesses. In The Start-Up City, Gabe Klein cites successful projects in which citizens, businesses and local government worked together



to make their city the talk of the nation by thinking as nimbly as a start-up.

True, things like zoning and tax incentives come under the

government, but what can a man who ran two DOT offices possibly teach about running an entire city, let alone a business? Plenty! Start Up City is a great book for change management ideas and for influencing how you redevelop a city (and business). When the government asked their "consumers" (citizens) what they wanted, or what needed improving, great ideas flooded in. When the government tried some

of these ideas on a small, pilot-project level, success bloomed. When the government created project portals with data-tracking and real-time reporting and responses, trust and support rocketed. When the government marketed what they were doing to help citizens "enjoy" the ideas, excitement grew. Word spread. Outsiders noticed.

When I went looking for a book that might support one of the quests of the township, I was excited that the lessons in Start-Up City can apply to any business, not just re-imagining a town. After all, thinking like a start-up evokes a sense of creative spirit, trail blazing, shaking up the status quo and having fun along the way.
