


#### What new grads and employers should know about the job outlook.

### The New Geography of Jobs

We've had the Great Depression, a Great Recession, and now we have something more viral and massively more impactful than the other "Greats" combined. Mr. Moretti labels it: "Great Divergence." The author reveals a new economic map, which has been unfolding these last 30 years and it is like nothing we've seen before in our history. It goes much deeper than a political Red and Blue divide. There is a noticeably huge divergence between the Have and the Have-nots. If your city hosts the right industry, with the right jobs, then you are fortunate. But if your city is in with the wrong industry- that industry will be like having a





parasite slowly and painfully draining your city dry.

Like a vicious cycle, educational levels of your citizens will make or break you. Edu-

cation levels affect productivity and salary gaps. The saying of' birds of a feather, flock together' couldn't be more applicable to city and citizen wellness. Education levels will attract or deter the right companies to your city. Highly paid citizens, with higher educational backgrounds, will spend, support and strengthen your city. Those well educated citizens, in high paying jobs will make your city look good, and in turn, will attract other good industries, with well-educated employees to you. On the flip side, the same holds true for cities that are rusting away, with salaries plummeting, citizens struggling, and certain industries corroding. ing, self sustaining, min-cities. They have work out centers, cafes and coffee houses, study hubs, and green spaces. Doesn't that sound awesome? What is the root of all this? Colleges caught on to a notion that they must create an environment

in which everyone wants to go there AND no one wants to really leave. Sadly, college grads are about to go from a decked-out college campus to a dreary work environment.

Ms. Groves argues that physical

space impacts the culture, productivity and longevity of your employees, no matter your size, revenue or product. Much like a college campus, the goal is to create a work environment in which everyone wants to work for you and they don't want to leave once they get there. Now, some of the environments in here are arguably over the top. Even I am not for "nap-pods,"

or playing tag with my CEO. True, work isn't adult day care, but it should have a pop of fun. For example, free stocked pantries and cafes: now that sounds nice when I am drained. Day care help on site: what a stress reliever. A va-

riety of indoor and outdoor gathering spaces, with the time and the permission to use them: refreshing. If you are going to "live at the office," spending 8-12 hour days at work, inject elements to make it a welcoming home away from home.
