# Small Businesses Must Be On Guard Against Scams

Part of creating a legal climate in Ohio that encourages business investment and generates jobs involves protecting both consumers and small businesses from fraud, scams, deceptive behavior, and unfair business practices. That's the mission of the Consumer Protection Section of the Ohio Attorney General's Office.

In 2012, the section received more than 1,000 complaints and helped adjust, recover, or save some \$160,000 for small businesses. The section offers the same dispute resolution services to small busi-

nesses and nonprofits that it makes available to consumers. And, together with regional representatives from the Attorney General's Office, the section's Education Unit reaches out to inform business owners of Ohio's consumer laws. Working through local chambers of commerce and independent business organizations, staff members conduct dozens of informational training sessions every year.

Just as consumers can benefit from an "ounce of prevention," businesses, too, should stay informed and alert to keep from becoming victims of fraud. Some of the scams aimed at Ohio businesses include:

- The Federal Trade Commission (FTC) scam: Be wary if your business receives emails that appear to be from the FTC scammers have sent thousands of these phony emails claiming that consumers have filed complaints about the recipients' businesses. For more information about this scam, click on www. businessftc.gov.
- Business directory scams: Scammers who pretend to represent local city government, chambers, or yellow pages call businesses, tell them it's time to renew their ad space in the local community map or directory, and use high-pressure tactics to get credit card numbers over the phone. The ads don't exist and the scammers steal money from the credit card numbers given to them in good faith.
- Government impersonation scams: Scammers offer to help businesses comply with new government regulations for a fee or pretend to be from the Secretary of State's office and ask for a payment to meet a new requirement. Free information is available to businesses in Ohio from their local or state governmental agencies. Scammers also call unsuspecting consumers, claiming to be from a court or a law enforcement organization, demanding money and threatening jail time. In fact, earlier this year our Help Center received reports of callers claiming to be from the Attorney General's Office and insisting that consumers use prepaid money cards to satisfy bogus debts. If a business or a consumer has a question about a debt owed, or possibly owed, they should contact our Collections Enforcement office at 877-607-6400.
- Fake invoice scams: Businesses that receive invoices for products or services they never ordered are often the targets of scammers who hope the businesses pay the fake invoices before they realize nothing was asked for or delivered.

Lies are the stock-in-trade of scammers and deceit is their standard operating procedure. They can only succeed if businesses don't pay attention. ### Take note of:


- New Meetings Styles – Yes, the suggestions here are different, and so much so that they are that breath of fresh air.

### **WORKERS' COMPENSATION**

Employers must report their payroll and pay workers' compensation premium for the 01-01-2013 through 06-30-2013 reporting period by 08-31-2013, in order to prevent a lapse in coverage. If you report and pay online through the BWC's website, www. ohiobwc.com, you can use the 50/50 plan and as well as earn a 1% rebate. 50/50 lets you pay only half your premium before 09-01-2013. The other half must be paid before 12-01-2013.

You can also earn up to 1.7% discount on the premium that may be due for payrolls incurred from 07-01-2013 through 12-31-2013 by paying it early.

Now is the time to see if you can cut your workers' compensation premium for 2014 through the Richfield Chambers' workers' compensation program.
