Art Thinking: How to Carve Out Creative Space in a World of Schedule, Budgets, and Bosses



In her new book Art Thinking, author Amy Whitaker explores how creative thought commonly practiced by artists and musicians can be applied to the business world. She provides a program to cultivate art thinking, and transform creative failure into progress, innovation, and new products and services. She writes that "this book is a meditation and a manual, a manifesto and a love story, for how art—creativity writ large—and business go together. It is about how to construct a life of originality and meaning within the real constraints of the market economy."

Whitaker's basic premise is that if you are creating a work of art or embarking on a new business scheme, you are not going from Point A to Point B, but rather inventing that point B. To reach point B, she offers a foundation to help en-

trepreneurs balance creative thought with pragmatic solutions. Whitaker provides examples from successful, athletes, scientists, managers, and writers to underscore her thesis. In addition, she points out that some of the greatest individuals (including



Michael Jordan, Dr. Seuss, and Elvis Presley) were initial failures in their respective fields.

The book is highly readable and stays away from technical business jargon. The tone is light, optimistic, and maybe a little too rosy in its outlook of how the worlds of "artistic expression" and "business results" can coincide. Art Thinking contains over 50 humorous line drawings and many fascinating

quotes to illuminate Whitaker's premise, such as Andy Warhol's statement that "being good in business is the most fascinating kind of art."
