Employees suffering from a variety of medical conditions, including colitis, epilepsy, Parkinson's Disease and cancer may soon be able to use marijuana as one protocol for medically treating his or her condition.



What does this mean for Ohio employers? On the one hand, employers are required to reasonably accommodate employee disabilities. On the other hand, your handbook clearly states that employees are prohibited from being under the influence of illegal substances while working. And marijuana is still a federal Tier 1 drug.


#### **BUSINESS BOOKS** For those of you who have time for only one business related book a month, the Richfield Branch Library has gone into the shelves to narrow down trending title suggestions.

#### From Global to Local: The Making of Things and the End of Globalization

#### By Finbarr Livesey Pantheon, 2017 ISBN-10: 1101871210

The accepted wisdom about globalization in the world economy assumes that it will continue to spread, that international trade is its growth engine and that economic power is slowly moving from West to East. In his new book, economist Finbarr Livesey questions that prevailing wisdom and makes the prediction that in the near future, global trade in goods will slow as businesses locate production closer to their customers.

Livesey cites four major reasons why this change is taking place. First, the economy will become much more highly automated than it is today, meaning that most labor will be done by machines rather than



cheap workers in the developing world. With more 3-D printers and robots doing most of the manufacturing, more highly skilled local workers will be needed to service these devices. Secondly, as wages in developing nations like China increase, moving manufacturing offshore becomes less attractive. Discover how the rising monetary and environmental costs of shipping will put a strain on companies to rethink the on-demand nature of consumerism; as well as how the rise of economic nationalism and protectionism throughout the world, will put pressure on companies to keep their workforce at home.

I liked the book and the way it questions the inevitability of a truly global economy. While its arguments seem to be good news for American corporations, Livesey points out that manufacturing in the future will need fewer and fewer workers, and those that remain will need highly technical skills to succeed.
