Revere Schools Asks Chamber for Levy Support

The Revere Local Schools are asking voters to approve a 4.85 mill Emergency Operating Levy on the November 2 ballot. Substantial budget reductions and employee salary concessions from teachers, non teaching personnel and administrators enabled the District to reduce the millage by 2.01 mills from the May 2010 levy request. Sound fiscal policies and careful spending have kept Revere off the ballot for ten years. In additions, during this 10 year period, the District's academic accomplishments have placed Revere as one of only eighteen schools in Ohio that have been academically excellent for eleven consecutive years. These

are both feats that few other Ohio school districts have been able to accomplish. Recently, a private accounting firm, a group of community members with financial expertise and the State Auditor's Office have carefully reviewed the District's finances or the five year forecast report. Each of these groups have validated the District's financial practices and projections. Passage of this levy is critical to maintain excellence

throughout the District.

Without this levy, further potential reductions in the amount of \$3 million dollars will be necessary for next school year. Reductions of this magnitude will dramatically impact course offerings, class size and other opportunities for students. Additionally, pay-to-participate fees of \$450 will be put in place for each high school sport and band or choir. Middle School sports and other activities will be eliminated. The excellence in education that is a tradition at Revere is not sustainable without additional funding. School funding in Ohio remains as an unresolved matter. The Plain Dealer recently wrote about the 42 schools in northern Ohio that will be on the ballot this November.

We are not alone in needing our communities financial support to continue our excellence. The levy will cost homeowners about 42 cents a day for each \$100,000 of home valuation.
