

Under the Occupational Safety and Health Administration (OSHA) recordkeeping and reporting regulations covered employers, with more than 10 employees or not in certain low-hazard industries, are

Bruce W. Baylor President required to prepare and maintain records of serious occupational injuries and illnesses, using the OSHA 300 Log. On September 11, OSHA announced changes to the list of industries that are exempt from the requirements to routinely keep OSHA injury and illness records.

OSHA also announced changes to the list of severe work-related injuries and illnesses that all covered employers must report to OSHA.

These new requirements will go into effect on January 1, 2015 for workplaces under Federal OSHA jurisdictions.

#### Public and private employers: Get ready for prospective billing

The Ohio Bureau of Workers' Compensation (BWC) is switching from retrospective billing to prospective billing starting in 2015. That means private and public employers will pay in advance of receiving workers' compensation coverage. According to Elizabeth Seufer, BWC public information officer, prospective billing will help BWC modernize its operations and provide better service to employers.

The switch will occur July 1, 2015, for private employers and Jan. 1, 2016, for public employers.

Learn more about the transition credit BWC will provide to employers in good standing as well as deadline changes for BWC rating plans and discount programs in this private employer prospective billing update and public employer prospective billing update.


