
## Nominate the Richfield Business of the Year

#### Simply Brilliant: How Great Organizers Do Ordinary Things in Extraordinary Ways

By William C. Taylor, Founder of Fast Company Portfolio, 2016 ISBN-10: 1591847753

In his new book, Simply Brilliant: How Great Organizations do Ordinary Things in Extrordinary Ways, William C. Taylor explores the ways enterprises in traditional and even unglamorous fields are using innovative business practices to achieve success.


When people think of companies that are world famous innovators, they usually think of Silicon Valley or groundbreaking startups like Uber or Airbnb, but surely not a company from Ohio. Traveling the country, Taylor examines how creative thinking is transforming organizations such as retail banks, office cleaning companies, department stores, and auto dealerships.

Taylor offers eight core insights to help businesses transform. These include building a unique definition of success that stands apart from the competition, embracing

the idea of "provocative competence", and a willingness to share the profits of success.

He states that "in a time of wrenching disruptions and exhilarating advances, ... the future is open to everybody."

I found the book to be most interest-



ing in the specific case studies of the various companies. These include Lincoln Electric in Euclid, Ohio, with its share-thewealth model that gives employees a vested interest in high quality and productivity; 1111 Lincoln Road in Miami Beach, which reimagined the parking garage as a public space that hosts weddings, yoga classes, and community gather-

ings; and Pal's Sudden Service, a fastfood chain that serves up burgers and fries with such speed and accuracy that companies from other industries pay to learn from its practices.
