#### Revere Renewal Levy Is on February Ballot

The Revere five-year renewal levy on the Feb. 8 ballot will not increase taxes. The fixed-sum emergency levy collects \$4.56 million annually and represents approximately 14 percent of the district's operating budget. This levy was first passed in 2001 for 6.9 mills and renewed in 2005. Because of new construction and the fixed sum nature of this renewal levy, the millage has decreased to 4.66.
