

#### Mayor Michael Wheeler

Mayor Michael Wheeler was born in Oklahoma but moved with his family at age two and grew up in California. He married Polly in 1984 and moved to Richfield in 1986. They



are blessed with four children, six grandchildren with a seventh on the way, and two guard dogs, also known as Chihuahuas. He calls them his wireless doorbells.

Mayor Wheeler attended Hoover High School in Fresno. He graduated from California State University at Fresno with a Bachelor of Science degree in marketing and management. He later earned an independent graduate degree in geochemistry from California State University at Bakersfield.

Wheeler worked in commercial real estate for seven years, including developing his own brokerage company. He and Polly started Wheeler Publishing Company in 1991 with just the two of them. The company, now known as Novex Systems, has since grown to over 100 employees.

Along the way Wheeler coached Little League baseball, football and soccer. In September 1986 he became an assistant scoutmaster with Boy Scout Troop 387 and continued until June of 2010.

He has volunteered with United Way, Open M, Girl Scouts, Revere Band, the Town Trust and the Sweet Corn Challenge event, and has given over eight gallons of blood to the Red Cross. Currently, he sits on the board of directors of three companies and is a member of the Richfield UCC, Masons and Kiwanis. He volunteered his expertise, products and services to help make the Richfield Heritage Preserve a dream come true.

Wheeler has been President of Bath Richfield Kiwanis, held the top offices in two Masonic organizations, served on his church council, and been president of the Village of Richfield Council. He currently serves as mayor of the Village of Richfield.

He enjoys camping with Polly, working out, and hiking on any one of our many park trails.
