#### Inflation Reduction Act caps insurance costs

One of the provisions of the federal Inflation Reduction Act requires Medicare-connected insurance plans to cap the out-of-pocket costs for the insured employee at \$2,000 per year. The requirement probably will impact employers who have 20 or more employees. These companies try to have health insurance plans that avoid Medicare's late-enrollment penalties for employees who stay on the employer-provided health plans past Medicare's usual enrollment age of 65. These employers' plans may need to cap out-of-pocket prescription costs at \$2,000.
